The filing period for United States Senator, United States Representative, State Representative, Chief Justice of the Minnesota Supreme Court, Associate Justice of the Supreme Court, Judge of the Minnesota Court of Appeals, and Judge of the District Court begins at 8:00 a.m., Tuesday, May 21, 2024, and ends at 5:00 p.m., Tuesday, June 4, 2024. (Note: Filing offices will be closed Monday, May 27, 2024, in observance of Memorial Day.)

The place of filing for federal offices is the Office of the Secretary of State, Veterans Services Building, 20 West 12<sup>th</sup> Street, St. Paul, MN 55155. The place of filing for state offices is with the Office of the Secretary of State or with the County Auditor of the county in which the candidate resides.

Candidates for county offices of County Commissioner and Soil and Water Conservation District Supervisor file with Blue Earth County Office of Elections, Blue Earth County Historic Courthouse, First Floor, 204 S. Fifth Street, Mankato, MN 56001. The filing period for county offices is the same as listed above. Candidates of county offices should visit www.blueearthcountymn.gov to learn about filing options or may file by mail if the filing is received during the filing period.

Candidates for judicial offices may file either with the Office of the Minnesota Secretary of State or with the County Auditor in the county where the candidate resides.

Candidates who will be absent from the state during the filing period and meet the requirements of Minnesota Statutes section 204B.09, subdivision 1a, may arrange to file during the seven days immediately preceding the candidate's absence from the state.

The filing period for presidential elector candidates begins at 8:00 a.m., Tuesday May 21, 2024, and ends at 5:00 p.m., Tuesday, August 20, 2024, for non-major political party candidates and independent candidates. The certification deadline for major political party presidential elector candidates is August 27, 2024. (Note: Filing offices will be closed Monday, May 27, 2024, in observance of Memorial Day, Wednesday, June 19, 2024, in observance of the Juneteenth Holiday, and Thursday, July 4, 2024, in observance of Independence Day.)
